This Standard was prepared by the Joint Standards Australia/Standards New Zealand Committee EL-002- Safety of Household and Similar Electrical Appliances and Small Power Transformers to supersede AS/NZS 60335.2.45:2004 two years from the date of publication. During this period it is anticipated that regulatory authorities will approve portable heating tools and similar appliances to either standard.

The principal changes in this edition as compared with the edition 3.1 of IEC 60335-2-45 are as follows (minor changes are not listed).

- It introduces requirements for induction soldering irons (11.3, 11.4, 13.1, 16.1 and 19.13).

The objective of this Standard is to provide manufacturers, designers, regulatory authorities, testing laboratories and similar organizations with safety requirements designed to give the user protection against hazards that might occur during normal operation and abnormal operation of the appliance and which may be used as the basis for approval for sale or for connection to the electricity supply mains in Australia and New Zealand

The text of IEC 60335-2-45 Ed 3.2, prepared by IEC Technical Committee 61, was submitted to the Standards Australia/Standards New Zealand Combined Procedure (dual public comment and committee vote) for adoption of the IEC standard as a Standards Australia/Standards New Zealand joint standard.

This Standard is an adoption with national modifications of the third edition of IEC 60335-2-45, *Household and similar electrical appliances – Safety – Part 2-45: Particular requirements for portable heating tools and similar appliances* including its amendment 1 (2008) and amendment 2 (2011). It has been varied as indicated to take account of Australian and New Zealand conditions.

This part 2 has to be used in conjunction with the latest edition of AS/NZS 60335.1 Household and similar electrical appliances – Safety – Part 1: General requirements and its Amendments. It was established on the basis of AS/NZS 60335.1:2011.

This part 2 supplements or modifies the corresponding clauses of AS/NZS 60335.1 so as to convert it into the Australian/New Zealand Standard: Safety requirements for portable heating tools and similar appliances.

When a particular subclause of Part 1 is not mentioned in this part 2, that subclause applies as far as is reasonable. When this standard states "addition", "modification" or "replacement", the relevant text of Part 1 is to be adapted accordingly.

NOTE 1 The following numbering system is used:

- subclauses, tables and figures that are numbered starting from 101 are additional to those in Part 1;
- unless notes are in a new subclause or involve notes in Part 1, they are numbered starting from 101, including those in a replaced clause or subclause;
- additional annexes are lettered AA, BB, etc.;
- subclauses, notes and annexes that are additional to those in the IEC standard are prefixed with the letters AZ.

The essential safety requirements in AS/NZS 3820¹ that could be applicable to requirements for portable heating tools and similar appliances are covered by this standard.

The national variations to IEC 60335-2-45 Ed 3.2 form the Australian and New Zealand national variations for purposes of the IECEE scheme for recognition of results of testing to standards for safety of electrical equipment (the CB scheme).

There are no national variations from the IEC Standard from which this standard is adopted, other than those listed in the national variations to AS/NZS 60335.1.

The following differences exist in the countries indicated below.

- 3.1.9: The conditions of normal operation are different for soldering guns and plastic-cutting tools (USA).
- 6.1: Class 0 appliances are allowed if their rated voltage does not exceed 150 V and class 0I appliances are allowed (Japan).
- 6.1: Class 0 soldering irons are allowed if their rated power input does not exceed 18 W (Poland).
- 6.1: Class I dehorning tools are allowed. Class 0 appliances are allowed if their rated voltage does not exceed 150 V and they are for indoor use only (USA).
- 11.7: The test for firelighters is different (USA).
- 11.8: The modification does not apply (USA).
- 21.101: The drop test is different (USA).
- 24.1.3: Switches are tested for 6 000 cycles of operation (Canada and USA).
- 25.7: Lighter cords are allowed (USA).
- 25.7: The modification does not apply (Japan).
- 25.8: Shorter supply cords are allowed for class II dehorning tools (USA).

The committee has decided that the contents of the base publication and its amendments will remain unchanged until the stability date indicated on the IEC web site under "<http://webstore.iec.ch>" in the data related to the specific publication. At this date, the publication will be

- reconfirmed,
- withdrawn,
- replaced by a revised edition, or
- amended.

NOTE 4 The attention of National Committees is drawn to the fact that equipment manufacturers and testing organizations may need a transitional period following publication of a new, amended or revised IEC publication in which to make products in accordance with the new requirements and to equip themselves for conducting new or revised tests.

It is the recommendation of the committee that the content of the amendment 1 be adopted for implementation nationally not earlier than 12 months or later than 36 months from the date of publication.

INTRODUCTION

It has been assumed in the drafting of this International Standard that the execution of its provisions is entrusted to appropriately qualified and experienced persons.

This standard recognizes the internationally accepted level of protection against hazards such as electrical, mechanical, thermal, fire and radiation of appliances when operated as in normal use taking into account the manufacturer's instructions. It also covers abnormal situations that can be expected in practice and takes into account the way in which electromagnetic phenomena can affect the safe operation of appliances.

This standard takes into account the requirements of IEC 60364 as far as possible so that there is compatibility with the wiring rules when the appliance is connected to the supply mains. However, national wiring rules may differ.

If an appliance within the scope of this standard also incorporates functions that are covered by another part 2 of IEC 60335, the relevant part 2 is applied to each function separately, as far as is reasonable. If applicable, the influence of one function on the other is taken into account.

When a part 2 standard does not include additional requirements to cover hazards dealt with in Part 1, Part 1 applies.

NOTE 1 This means that the technical committees responsible for the part 2 standards have determined that it is not necessary to specify particular requirements for the appliance in question over and above the general requirements.

This standard is a product family standard dealing with the safety of appliances and takes precedence over horizontal and generic standards covering the same subject.

NOTE 2 Horizontal and generic standards covering a hazard are not applicable since they have been taken into consideration when developing the general and particular requirements for the IEC 60335 series of standards. For example, in the case of temperature requirements for surfaces on many appliances, generic standards, such as ISO 13732-1 for hot surfaces, are not applicable in addition to Part 1 or part 2 standards.

An appliance that complies with the text of this standard will not necessarily be considered to comply with the safety principles of the standard if, when examined and tested, it is found to have other features that impair the level of safety covered by these requirements.

An appliance employing materials or having forms of construction differing from those detailed in the requirements of this standard may be examined and tested according to the intent of the requirements and, if found to be substantially equivalent, may be considered to comply with the standard.

HOUSEHOLD AND SIMILAR ELECTRICAL APPLIANCES – SAFETY –

Part 2-45: Particular requirements for portable heating tools and similar appliances

1 Scope

This clause of Part 1 is replaced by the following.

This International Standard deals with the safety of **portable electric heating tools** and similar appliances, their **rated voltage** being not more than 250 V.

Appliances not intended for normal household use, but which nevertheless may be a source of danger to the public, such as appliances intended to be used by laymen in shops, in light industry and on farms, are within the scope of this standard.

Appliances that may also be used when mounted on a support are within the scope of this standard.

NOTE 101 Examples of appliances that are within the scope of this standard are

- **branding tools;**
- **burning-in pens;**
- **conduit-soldering tools;**
- **dehorning tools;**
- **desoldering irons;**
- **firelighters;**
- glue guns;
- heat guns;
- **household film-welding appliances;**
- paint strippers;
- plastic-cutting tools;
- **soldering guns;**
- **soldering irons;**
- stripping pliers;
- **thermoplastic conduit-welding tools.**

As far as is practicable, this standard deals with the common hazards presented by appliances which are encountered by all persons in and around the home. However, in general, it does not in general take into account

- persons (including children) whose
 - physical, sensory or mental capabilities; or
 - lack of experience and knowledgeprevents them from using the appliance safely without supervision or instruction;
- children playing with the appliance.
