This Standard was prepared by the Joint Standards Australia/Standards New Zealand Committee EL-002 - Safety of Household and Similar Electrical Appliances and Small Power Transformers.

The objective of this Standard is to provide manufacturers, designers, regulatory authorities, testing laboratories and similar organizations with safety requirements designed to give the user protection against hazards that might occur during normal operation and abnormal operation of the appliance and which may be used as the basis for approval for sale or for connection to the electricity supply mains in Australia and New Zealand.

The text of IEC 62841-3-13 Ed 1, prepared by IEC Technical Committee TC 116, was submitted to the Standards Australia/Standards New Zealand Combined Procedure (dual public comment and committee vote) for adoption of the IEC standard as a Standards Australia/Standards New Zealand joint standard.

This Standard is an adoption with national modifications of the first edition of IEC 62841-3-13 *Electric motor-operated hand-held tools, transportable tools and lawn and garden machinery – Safety – Part 3-13 Particular requirements for transportable drills*. It has been varied as indicated to take account of Australian and New Zealand conditions.

This part 2 has to be used in conjunction with the latest edition of AS/NZS 62841.1 *Electric motor-operated hand-held tools, transportable tools and lawn and garden machinery – Safety – Part 1: General requirements* and its Amendments. It was established on the basis of AS/NZS 62841.1:2015.

This part 2 supplements or modifies the corresponding clauses of AS/NZS 62841.1 so as to convert it into the Australian/New Zealand Standard: Safety requirements for appliances for transportable drills

When a particular subclause of Part 1 is not mentioned in this part 2, that subclause applies as far as is reasonable. When this standard states "addition", "modification" or "replacement", the relevant text of Part 1 is to be adapted accordingly.

NOTE 1 The following numbering system is used:

- subclauses, tables and figures that are numbered starting from 101 are additional to those in Part 1;
- unless notes are in a new subclause or involve notes in Part 1, they are numbered starting from 101, including those in a replaced clause or subclause;
- additional annexes are lettered AA, BB, etc.;
- subclauses, notes and annexes that are additional to those in the IEC standard are prefixed with the letters AZ.

NOTE 2 The following print types are used:

- requirements: in roman type;
- *test specifications: in italic type;*
- notes: in small roman type.

Words in **bold** in the text are defined in Clause 3.

p NOTE 3 In this document, p is used in the margin to indicate instructions for preparing a consolidated version.

The essential safety requirements in AS/NZS 3820¹ that could be applicable to requirements for transportable drills are covered by this standard.

The national variations to IEC 62841-3-13 Ed 1 form the Australian and New Zealand national variations for purposes of the IECEE scheme for recognition of results of testing to standards for safety of electrical equipment (the CB scheme).

Part 3-13: Particular requirements for transportable drills

1 Scope

This clause of Part 1 is applicable, except as follows:

Addition:

This part of IEC 62841 applies to transportable **drills**, with manually fed axial movement of the spindle, having a maximum chuck capacity of 13 mm.

NOTE 101 Transportable **drills** are also known as bench **drills** or drill presses.

This part of IEC 62841 does not apply to stationary drilling machines.

This part of IEC 62841 does not apply to radial arm drills.

This part of IEC 62841 does not apply to magnetic drill stands and drill motors.

NOTE 102 Magnetic drill stands and drill motors will be covered by a future part of IEC 62841-3.

NOTE 103 In Europe (EN 62841-3-13), the following conditions apply:

Radial arm drills and stationary drilling machines are covered by EN 12717.

3.2 accessory

Addition:

Note 1 to entry: Typical **accessories** for **drills** are bits for drilling and deburring.

3.101 drill

tool equipped with a typical three jaw chuck specifically designed to bore holes in various materials such as metal, plastics, wood, etc., consisting of a **drill unit** and a **drill stand**, see Figure 101

Note 1 to entry: The **drill unit** or the chuck is manually moved up and down by a means such as a hand wheel or lever.

3.102 drill unit

device consisting of a motor and the chuck
