Preface

This Standard was prepared by the Joint Standards Australia/Standards New Zealand Committee EL-059, Dishwashers, Clothes Washers and Dryers, to supersede AS/NZS 2007.2:2005, *Performance of household electrical appliances — Dishwashers, Part 2: Energy efficiency and labelling requirements*.

The objective of this Standard is to specify the energy efficiency labelling requirements for electric household dishwashers that are within the scope of the relevant legislation.

This Standard defines performance and energy efficiency labelling requirements that a household dishwasher is to meet in order to be supplied in Australia and New Zealand.

This Standard does not specify safety requirements.

The AS/NZS 2007 series comprises two parts, as follows:

AS/NZS 2007.1, *Performance of household electrical appliances — Dishwashers, Part 1: Methods for measuring performance, energy and water consumption*

AS/NZS 2007.2, *Performance of household electrical appliances — Dishwashers, Part 2: Energy efficiency labelling requirements* (this Standard)

The parts of this series are summarized as follows:

- (a) *Part 1* — Specifies performance test procedures and minimum performance criteria for dishwashers.
- (b) *Part 2* — Includes algorithms for the calculation of the energy efficiency star rating and comparative energy consumption, performance requirements, details of the energy rating label and information on the requirements for the valid application for registration for energy efficiency labelling. It also includes information for registration for water efficiency labelling. Part 2 is to be used in conjunction with Part 1.

The overall objective of the AS/NZS 2007 series is to promote high levels of performance, energy efficiency and water efficiency in electric dishwashers.

The main changes in this Standard are as follows:

- (i) Addition of a super-efficiency 10-star label and element alignment with other energy-regulated appliances.
- (ii) Definition of multi-compartment dishwashers.
- (iii) The test voltage is specified as 230 V.
- (iv) The relevant legislation is described.

As documented in ISO 80000-1, *Quantities and units — Part 1: General*, the SI unit for litres may be either “L” or “l”. For the purpose of this document, and in conformance with Australian and New Zealand Standards, “L” is used as the unit for litres.

This Standard has been developed in consultation with regulatory authorities and is intended to be considered with reference to the relevant legislation. This Standard refers to AS/NZS 2007.1 for test procedures. AS/NZS 6400, *Water efficient products — Rating and labelling* references this Standard for water efficiency labelling requirements.

When check testing is undertaken, it will be to the relevant legislation to which the model has been registered. Check testing tolerances for all parameters in this Standard (including energy and performance) and details concerning check testing policies and tolerances are available at: www.energyrating.gov.au.

The terms “normative” and “informative” are used in Standards to define the application of the appendices or annexes to which they apply. A “normative” appendix or annex is an integral part of a Standard, whereas an “informative” appendix or annex is only for information and guidance.

Section 1 Scope and general

1.1 Scope

This Standard specifies the energy efficiency labelling requirements for electric household **dishwashers** that are within the scope of the **relevant legislation**.

In particular, this Standard specifies the following:

- (a) **Program for energy efficiency labelling** and water efficiency labelling.
- (b) Water connection mode.
- (c) **Comparative energy consumption (CEC)**.
- (d) **Star rating** for energy efficiency labelling.
- (e) **Energy rating label** requirements.
- (f) Performance criteria.
- (g) Content, format and affixing requirements for **dishwasher energy rating labels**.
- (h) Test report content, example for the application for **registration** for energy efficiency labelling and water efficiency labelling.
- (i) Details concerning appliance **registration** with the relevant regulator.

This Standard **shall** be read in conjunction with AS/NZS 2007.1.
